The Child Nutrition (CN) Labeling Program is a voluntary Federal labeling program run by the USDA. Through this program, the formulations of our products were examined by USDA to determine their contribution toward meal pattern requirements. This oversight allows us to state this contribution on our labels with the USDA certification and seal. The benefit of a CN label is that it clearly identifies the contribution of a product toward the meal pattern requirements. For products that carry a CN Label, schools should save an original CN Label from the product carton, or a photocopy or a photograph of the valid CN Label.

For a product to carry a CN label, the end product must first be evaluated by the USDA Food and Nutrition Service (FNS) to determine its contribution toward the meal pattern and then be produced under federal inspection by the USDA or the U.S. Department of Commerce. The CN

Label Program provides a USDA-approved method to document processed end products' contribution to the meal pattern.


Per USDA Policy Memo [#SP 05-2025 CACFP 04-2025 SFSP 02-2025](#), reviewers must not request a PFS or additional crediting information when a valid CN Label or watermarked CN Label is provided by program operators. The PFS should only be requested when reviewing a processed product without a CN Label
